TO INTRODUCE

THE DRAFT RESOLUTION "GLOBAL TOURISM RESILIENCE DAY" DURING THE 58th PLENARY MEETING OF THE GENERAL ASSEMBLY

6TH FEBRUARY 2023

Mr. President,

At the onset, please allow me to express the deepest condolences from the Government of Jamaica to the Governments and peoples of Türkiye and Syria, on the loss of lives and the damage to infrastructure, following the devastating earthquake. We stand in solidarity with you and welcome the humanitarian efforts for rescue and recovery being mobilized by the international community and the relevant UN agencies.

I have the honour to introduce Draft Resolution L.43 entitled "Global Tourism Resilience Day", tabled by Jamaica on behalf of a core group of Member States, including **The Bahamas**, **Botswana**, **Croatia**, **Cuba**, **Dominican Republic**, **Greece**, **Guyana**, **Jordan**, **Kenya**, **Malta**, **Namibia**, **Portugal**, **Saudi Arabia** and **Spain**, for the designation of 17 February annually as Global Tourism Resilience Day.

In the aftermath of the COVID-19 pandemic, the notion of "tourism resilience" has been placed at the forefront of the global discourse on the future and sustainability of international tourism. While travel and tourism has been traditionally considered one of the most resilient segments of the global economy, it has also proven to be simultaneously and disproportionately prone to shocks, especially due to the impact of disruptive events on perceptions of destination attractiveness and security.

Such disruptive events include natural disasters, climate change impacts and bio-diversity loss, food insecurity, political instability and conflicts, the threat of terror attacks, cyber-crime and cyber security issues, economic recessions and, indeed, epidemics and pandemics, as exemplified by the COVID-19 crisis. For an increasing number of tourism-dependent countries, like Jamaica, the process of recovery and resilience-building remains particularly important given the intricate link to social stability and enhanced economic growth. Within the context of the 2030 Agenda, sustainable tourism is firmly positioned in the sustainable development goals. Globally, the industry is one of the top drivers of economic activity with its wide and varied linkages into other sectors. The widespread social and economic implications of the COVID-19 pandemic on the global tourism industry have reinforced the need to leverage our collective efforts and creativity to ensure the survival continued growth and development of this crucial industry.

Mr. President,

For this reason, we firmly believe that the recognition and commemoration of a **Global Tourism Resilience Day** will encourage broad-based examination and pursuit of resilience-building efforts in this sector, including towards the attainment of Agenda 2030. Furthermore, the observance of the day is expected to raise awareness, ambition and action of global tourism stakeholders towards strengthening the industry's capacity to effectively mitigate, manage and recover quickly from major disruptions.

It will serve to encourage stakeholders – from governments to private sector to civil society and academia - to plan for and take action to confront challenges posed by health, technological and environmental disruptions, to ensure that destinations are prepared to manage crises which threaten the travel and tourism sector.

We recall the initiative by the President of the General Assembly to convene the first high level thematic debate on tourism on 4 May 2022 in New York, which signaled the re-emerging focus and the recognition of the role played by this crucial industry in attaining national and international development goals.

The thematic debate reiterated the necessity of adopting a multidisciplinary and multi-sectoral approach to tourism guided by the tenets of leaving no one behind. It emphasized the need to develop inclusive tourism, ramp up a climate friendly transformation of the tourism value chain, and raise public awareness of the important role that tourism plays in the sustainable development of our respective countries from the social, economic and environmental perspectives.

Adoption of this resolution will continue the momentum by increasing the widespread support of the international community to complement other processes within the United Nations system. I look forward to the adoption of the draft and future collaborative efforts among Member States and other stakeholders on its implementation.

In this vein, Jamaica will commence the commemoration of the Global Tourism Resilience Day with the convening of the inaugural **Global Tourism Resilience Day Conference 2023**. The Conference will be held from 15 to 17 February 2023, in Kingston and will have participation by leaders, tourism interests and academics from all regions both in person and in virtual format.

We look forward to the vibrant discussions and outcomes that will emanate from the Conference and are confident that they will be a valuable contribution to the global discourse on resilience and sustainability in the industry. To this end, Jamaica has already established eight Global Tourism Resilience Centers across the world and will continue to advocate for the establishment of other centers as a key mechanism to strengthen the tourism sector in conjunction with the relevant partners in the UN System.

Mr. President,

I take this opportunity to thank the members of the core group of countries for their invaluable contribution to advancing this worthwhile initiative. We express our gratitude to the many delegations from all regions that have co-sponsored and offered support for the draft. The consensus adoption of this important resolution signals our shared commitment to act now to showcase, improve and ensure global tourism resilience, which will be in the interest of our individual countries and the global collective.

As we celebrate today, the birth of one of Jamaica's most outstanding sons, the Honourable Robert Nesta Marley, we are reminded of the powerful message of strength and resilience, principles embodied in the resolution before us today.
