### INVITATION TO BID (Revised)

The PERMANENT MISSION OF THE REPUBLIC OF THE PHILIPPINES TO THE UNITED NATIONS IN NEW YORK invites all interested bidders/parties to submit bids for the following motor vehicle on an **"AS IS, WHERE IS BASIS"**:

The total price of the motor vehicle is **SIX THOUSAND EIGHT HUNDRED AND SEVENTY US DOLLARS (US\$6,870.00)**.

An auction bond of US\$687.00, in the form of cash or Manager's check issued to the Philippine Mission to the UN, is required with the bid. Upon determination of the awardee, the bid bond will be considered as partial payment for the vehicle, and the difference between such payment and the offered bid price shall be paid in the form of cash, Manager's check of a reputable bank in the City of New York. Full payment shall be made within five (5) working days from the date of the Notice of Award. In case of failure to pay within the prescribed period, the awardee may be penalized through cancellation of the award and forfeiture of the bid bond in favor of the Philippine Mission.

Auction bonds of non-winning bidders shall be returned within seven (7) calendar days after the announcement of the winning bidder.

The winning bidder of the motor vehicle shall pay, in addition to the purchase price, any taxes, custom duties, cost or charges of any kind or nature whatsoever levied in connection with the sale of the property. All expenses incidental to the pick-up of the vehicle shall be borne by the winning bidder.
