It is the BAC's understanding that the W9 is used by businesses to get information from vendors they hire as independent contractors (also called freelancers).</p> <p>BAC will determine acceptability of the W9 in lieu of the required Registration Certificate upon verification with the New York State Department of Taxation and Finance.</p>
2	<p>Necessity of Audited Financial Statements (AFS)</p> <ul style="list-style-type: none"><li>Bank Statement stating "number of digits" maintained by the company/depositor in lieu of AFS</li><li>Dun &amp; Bradstreet Scores (Credit report for Businesses) in lieu of AFS</li></ul>	<p>In lieu of an AFS, bidders can submit an Income Statement or Tax returns.</p> <p>An income statement is one of the three important financial statements used for reporting a company's financial performance over a specific accounting period, with the other two key statements being the balance sheet and the statement of cash flows.</p> <p>All documents submitted by bidders are treated with confidentiality.</p>

3	Evaluation of Bids	The Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
