The Chairman, Department of Procurement Committee (DPC) of Ceylon Shipping Corporation Ltd (CSC) under Ministry of Ports and Shipping of Government of Democratic Socialist Republic of Sri Lanka, hereby invites eligible Dry-Bulk ship owning companies/ Charterer/ Operators/ Managers to express their interest for registration in Partnering with CSC for the carriage of coal by deploying of their vessels for the Lakvijaya Power Plant (LVPP) at port of Puttalam, Sri Lanka for the ensuing season 2020/2021.

**Conditions :**

- (a) Interested parties are invited to provide the detailed descriptions of their vessels fleet for the Registration . The minimum specifications of the ships to be deployed shall be as follows;
- **Age :** less than 15 years
  - **Dead Weight Carrying Capacity (DWCC) :** 60,000 MT +/- 5 % More Or Less Owner's Option (MOLOO)
  - **Cranes MT :** 04 Electro-hydraulic cranes with minimum SWL of 30 MT
  - **Grab capacity :** minimum 10 CBM
