**INVITATION FOR BIDS**

1. The Democratic Socialist Republic of Sri Lanka has received a loan from Japan International Cooperation Agency ( JICA ) towards the cost of Health and Medical Service Improvement Project ( HaMSIP ) It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **Procurement of Equipment for MLT Training Schools and Bio-Medical Engineering Services Division of Ministry of Health .**
2. Bidding will be conducted through procedures in accordance with the applicable guidelines for Procurement under Japanese ODA Loans , and the **Prime Contractor shall be a Japanese National** as defined in the Loan Agreement .
3. **The Chairman , Ministry Procurement Committee - A of Ministry of Health** on behalf of the **Employer** now invites sealed bids from eligible bidders for the above Supply of Equipment and some of the eligibility criteria highlighted in the bid document are below .

5. The provisions in the Instructions to Bidders ( ITB ) and in the General Conditions of the Contract ( GCC ) are the provisions of the Standard Bidding Documents ( SBD – Goods ) under Japanese ODA Loans for Procurement of Goods ( Equipment )
6. **A pre-bid meeting will be held on 03<sup>rd</sup> December 2021 at 10.30 am , at the office of the Additional Secretary ( Procurement ) Ministry of Health , No. 26 ( 2<sup>nd</sup> floor ) , Sri Sangaraja Mawatha , Colombo 10 .**

8. Bidding will be according to the Two Envelopes system . Accordingly the sealed original and duplicate bids , should be in separate envelopes and marked as “ **Bids for Package No 06 of JICA /HAMSIP project** ” on the top-left hand corner , and submitted to the “ **Procurement Division of the Ministry of Health , No 26 ( 2<sup>nd</sup> floor ) , Sri Sangaraja Mawatha , Colombo 10 ; before 10.am on 21<sup>st</sup> January 2022 .**
9. The bids shall accompany a bid security as stipulated in table of the paragraph 3 above . The form of the Bid Security shall be an unconditional guarantee issued by a Local Bank registered and authorized by the Central Bank of Sri Lanka .
10. Technical Bids will be opened in the presence of the Bidders ( Prime Contractors ) or the said Bidder’s representatives , who chose to attend the **Procurement Division of the Ministry of Health , No. 26 ( 2<sup>nd</sup> Floor ) , Sri Sangaraja Mawatha , Colombo 10 ; soon after the closing of the Bidding .**
